Please Note: A copy of your dog's vaccination records must be attached to this agreement in order for your dog to be enrolled in daycare. Required current vaccinations include: rabies, DHLPP and Bordetella. Also, your dog must be on a flea preventative and have a negative fecal exam. All daycare package expires after 6 months of purchase date.

This agreement between Augusta Dog Training (herein after referred to as "Augusta") and the pet owner, whose name is set forth above (herein after referred to as "Owner"). Augusta shall exercise due and reasonable care to keep Augusta premises sanitary and properly enclosed. The dogs shall be housed in clean safe quarters and fed and watered regularly. The dog (s) shall be handled and/or cared for by the Augusta staff. The owner agrees to hold Augusta harmless for any loss to owner's dog (s) from disease, theft, fire, escape or injury, including injury by other dogs, or for any other unavoidable causes, provided Augusta has exercised due diligence and care for the dog while performing duties hereunder.

If the dog (s) becomes ill or if the condition of the dog's health otherwise requires professional attention, Augusta, at its sole discretion, may retain the services of a licensed veterinarian of its choosing or administer medicine or give other requisite attention to the dog (s). The owner shall be solely responsible for any expenses relating to the care of the dog (s). Daycare charges shall be processed at the dates and times entered on our daycare roster sign-in. Owner shall notify Augusta in advance is there are any changes in date or times dog (s) are to be dropped off or picked up. The dog (s) shall be picked up by owner or pre-approved individual prior to 7:00 pm. Dogs picked up after 7:00 shall be charged \$1.50 per minute starting at 7:00 pm until picked up by before 7:30. If dog (s) are not picked up by 7:30 dog (s) shall be boarded overnight at Augusta's Montgomery location. Owner agrees to pay a boarding fee of \$39.95 per night plus a \$50 trip charge for dogs' transportation to and from the Montgomery location. Dogs will not be available for pick up once they are in route to and are at the Montgomery facility. Dog (s) shall not leave Augusta until owner pays for any and all unpaid charges resulting from daycare and boarding at Augusta. **Owner acknowledges that trainers are not authorized to release dog (s).**

Dog (s) will be playing in open areas with other dogs. Although each playgroup will be supervised and great care will be taken to ensure that the dogs do not harm one another the possibility of injury does exist. Owner shall be responsible for any harm caused to any other dog (s) or any humans while on Augusta premises. Dogs may be kenneled for up to four hours throughout the day for rest periods.

Owner agrees to indemnify and hold Augusta harmless for any and all costs, expenses and liabilities that may arise from the acts of Owner's dog (s) . Owner hereby releases and forever discharges Augusta from any and all claims, actions, causes of action, demands, rights, damages, costs, and expenses which may arise due to injury to person, property or dog while Owner or Owner's dog is on Augusta premises. Owner agrees that their dog may be videotaped, photographed and/or recorded (hereinafter referred to as "Media"). Augusta shall be the exclusive owner to the results of such Media. Augusta shall have the right to use said Media into perpetuity. Owner further agrees that their dog (s) may be used in any and all forms of media and in the promotion, advertising, sale, publicizing and exploitation of Augusta and its facilities. Augusta and Owner agree that all provisions of this contract shall be binding upon both parties for Owner's dog (s)' current visit and for all subsequent visits to Augusta. This contract contains the entire agreement between the parties. It is understood that the Owner has read and understands the rules and regulations set forth in this Agreement. The Owner agrees to abide by the rules and regulations and accepts all of the terms, conditions, and statements of this Agreement.
